Mr Syed Amsyar bin Ahmad Alhamid, a student with CPAS School

Since young, Amsyar experienced delayed motor development, a result of being diagnosed with spastic diplegia at birth as he was born prematurely at 32 weeks. In Amsyar's early years, he had difficulties standing, walking and communicating. His parents enrolled him in Cerebral Palsy Alliance Singapore (CPAS) School, and it was a turning point for Amsyar. His speech, mobility, writing and texting skills improved tremendously due to the support provided by trained Teachers, Speech & Language Therapists, Physiotherapists and Occupational Therapists. His mobility skills improved from using a kaye walker to walking independently, and gaining the ability to converse in public further elevated his confidence. Now, Amsyar enjoys helping his teachers, from running errands for school staff to pushing his classmates on wheelchairs. He is brimming with potential and Amsyar's parents and teachers are confident that with the continued support from the community, Amsyar would eventually be able to commute independently and secure a suitable job upon graduation from school.

Mr Kamsan Amin and his family former clients of South Central Community Family Service Centre

Diagnosed with Stevens-Johnson syndrome (a rare, serious disorder of the skin and mucous membranes) that eventually robbed him of his sight, Mr. Kamsan Amin was dealt a hard blow in life that only worsened as he found himself struggling to provide for his three children as a single parent. Despite the harsh reality of his situation, Kamsan remained positive and concentrated on his goal of providing them with an education. He lived simply, in order to afford laptops and other gadgets that can assist and motivate his children in their studies. Together with the support of teachers and financial assistance from South Central Community Family Service Centre, his children thrived. Today, his eldest daughter is a diploma holder, while his son and youngest daughter study Chemistry at the National University of Singapore. To Kamsan, his goal has been realised. "I hope my children can be professional, not just in their work, but also in their way of life, and give back to the community," he adds.

WORKFORCE SINGAPORE

A statutory board under the Ministry of Manpower, Workforce Singapore (WSG) is an organisation concerned with the creation of quality jobs across various work sectors, the provision of manpower support, and keeping workers employable in our current economic climate. Over the years, WSG has consistently shown its support for Community Chest with its involvement in the SHARE programme. This year, despite the COVID-19 pandemic, its employees were not deterred from continuing to support the programme. Aware of the impact that the pandemic would have on the lives and livelihoods of vulnerable communities, the Chief Executive of WSG. Mr Tan Choon Shian made a special call-out to its employees during a staff event in early 2020 and urged them to increase their current contribution in the SHARE programme. To do so, staff simply had to scan a QR code to indicate the additional amount that they would like to contribute. The ease of use led to the desired result of staff donating above and beyond their current contributions, resulting in an overall increase in the company's monthly SHARE contribution. On top of being an advocate of Community Chest's monthly giving programme, WSG also conducted an internal online charity auction, where staff gave generously to beneficiaries with special needs. With a belief that it is especially crucial for an organisation like it to provide support for our vulnerable communities especially during this pandemic, WSG has pledged steadfast support to Community Chest and its current and future initiatives.

RAFFLES HOTEL SINGAPORE

Raffles Hotel Singapore shares a longstanding relationship with Community Chest spanning decades. An iconic global symbol of hospitality that is synonymous with Singapore for over a century, Raffles has cultivated a strong sense of social responsibility among its colleagues to contribute to the community regularly. Following this National Monument's reopening in late 2019 after a two year-long second restoration, it continued its partnership with Community Chest with the aim to bring the Singapore community even closer to its heritage through the Raffles Reopening Festival, with proceeds from its ticket sales going towards the 80 social service agencies supported by Community Chest. A total of \$1 million was donated to Community Chest, with \$600,000 raised from the Reopening Festival and a further \$400,000 raised from a private silent auction. Raffles Hotel Singapore also runs a regular Raffles Outreach Program to spread cheer to the vulnerable groups, where hotel colleagues visit community homes, hospitals, old age homes and orphanages to deliver festive cheer and organise outings for the service users. Despite being in an industry heavily impacted by the COVID-19 pandemic, Raffles Hotel colleagues remain committed to caring for vulnerable groups, with a strong belief that their efforts are more needed now than ever.

Established in 1959, the Real Estate Developers' Association of Singapore (REDAS) strongly believes in its civic duty to give back to Singapore by meeting the needs of the underserved. REDAS had organised fundraising golf tournaments before moving on to set up the REDAS Foundation in 2013, with the purpose of providing support for social service agencies through the funding of their community programmes and activities. The company further boosted their giving efforts in 2019 by supporting the KidSTART programme, an initiative that benefits children from low-income families. PAN PACIFIC HOTELS GROUP

The Pan Pacific Hotels Group (PPHG) has been in partnership with the National Council of Social Service (NCSS), since the joint launch of the Eat Well With Us programme in 2015. As part of PPHG's corporate volunteerism effort, the inaugural community outreach programme saw its senior chefs conduct regular visits to four charity homes AWWA Senior Community Home, Bright Hill Evergreen Home, Melrose Home Children's Aid Society and Singapore Cheshire Home to impart their culinary skills and recipes to the resident cooks, so that they could recreate healthy and tasty dishes for its 600 residents. Over the past three years, employees from the company also volunteered their time visiting and serving the residents at festival occasions.

The initiative was given a new lease of life in 2019, when Unilever Food Solutions (UFS) and Mount Alvernia Hospital came onboard the programme, which led to an enhanced outreach to over 4.000 residents in 20 charity homes island-wide including Sree Narayana Mission Nursing Home, Society for the Aged Sick and Bishan Home for the Intellectually Disabled. The success of the Eat Well With Us programme was made possible through the sponsorship of a central kitchen facility by UFS, as it enabled PPHG's chefs to expand on the culinary training provided. Additionally, under the guidance of Mount Alvernia's nutritionists, the chefs were empowered to design modules and develop improved, nutritious recipes for their culinary workshops, which in turn, benefitted the resident cooks and residents of the charity homes. The giving of PPHG's time and talent through this collaborative hands-on effort is a testament to the commitment they share with Community Chest, towards building a caring and inclusive community.

Leading e-commerce platform Lazada Singapore embarked on its first-ever partnership with Community Chest (also the company's first with a non-profit organisation) in late 2019 with the launch of the latter's digital fundraising initiative, Add A New Story. Taking full advantage of its digital assets, Lazada amplified the publicity efforts for Add A New Story by providing substantial media support on its social media and e-commerce platforms, which command a large following and traffic volume respectively. Additionally, they leveraged key shopping dates like 11.11 and Black Friday during the shopping season in November and December to encourage year-end giving amongst its users. The partnership also attracted media coverage in various print and online media spaces that helped further bolster campaign efforts. Having explored fundraising within the digital space with Add A New Story, the partnership inspired Lazada to commemorate their 8th anniversary with Community Chest in March 2020 with a fundraising campaign of their own, in which it pledged to dollarmatching for all donations, up to \$100,000. Through this impactful partnership, Community Chest has been able to leverage Lazada's extensive reach in the e-commerce space to reach out to new donors through meaningful and unique digital engagements.

Over the years, the People of Purpose program has encompassed multiple diverse volunteering initiatives in support of Community Chest. This year, the COVID-19 pandemic challenged DBS to find new and innovative volunteering formats amid social distancing restrictions, which resulted in the roll out of Singapore's largest virtual befriending volunteer initiative with Lions Befrienders, where tablets donated to the elderly beneficiaries enabled them to connect remotely with DBS' staff volunteers. This initiative helped alleviate feelings of loneliness amongst vulnerable seniors as they participated in meaningful interactions with staff, including online games and singalongs. Apart from volunteerism at an institutional level, DBS also encourages its employees to initiate ground-up programmes of their own to mobilise their fellow colleagues, while senior management often lead by example by fully utilising their two-day volunteer leave each year. This has resulted in a multiplier effect, with volunteerism becoming an integral part of staff culture. The championing of active volunteerism on top of corporate giving demonstrates DBS' devotion to nurturing inclusivity within the larger community.


AWARDS CRITERIA AND ELIGIBILITY

PINNACLE AWARD

The Pinnacle Award is the highest honour conferred by Community Chest to recognise and thank an organisation for its exemplary efforts in holistic caring and the excellent example it sets as a role model in the following three aspects:



The nominee organisation must be eligible for firstly, a SHARE Award or Charity Award and secondly, a Volunteer Partner or Enabler Award. Besides the presentation of the Pinnacle Award to showcase an organisation that leads the wave in the giving of its time and treasures, the organisation must also incorporate sustainable and inclusive employment measures such as:





SINGAPORE TELECOMMUNICATIONS LIMITED (SINGTEL)

Singtel is committed to enabling the sustainable progress, development and inclusion of vulnerable groups in society through a multi-stakeholder approach of key partnerships, programmes and staff engagement initiatives.

Singtel has been a long-term supporter of persons with disabilities and children and youth with special needs. Its corporate philanthropy programme the Singtel Touching Lives Fund, which has raised over S\$45 million since 2002, works with special education schools to equip children and youth with special needs with the skills needed to lead independent and meaningful lives.

Beyond education, Singtel's support extends to preparing students with special needs and disabilities for the transition to the workforce. The Singtel Enabling Innovation Centre provides them with contact centre skills and customised ICT training through assistive technologies to enhance employment opportunities. Singtel partners SG Enable in its internship and mentorship programmes, placing students in business units for them to gain work experience and mentoring from staff and business leaders.

At its offices, Singtel creates a conducive working environment for persons with disabilities through job redesign, workplace adjustment and integration, and staff inclusion training. It also consults social service agencies like SG Enable and SPD for accessibility assessments and conducts disability awareness training for frontline employees in its retail stores.

As part of its efforts to advance the disability inclusion agenda in Singapore, Singtel also promotes dialogue with the business community. It leverages its position as a founder and co-chair of the Singapore Business Network on Disability to encourage the crosssharing of related expertise, experiences and resources between business partners and industry peers. For example, it rallies fellow member companies to participate in university career fairs and CV clinics for tertiary students with disabilities.

Singtel's holistic inclusion strategy in all facets of its businesses has had a significant positive impact on the community. As it continues to support inclusive employment, digital inclusion and enabling technologies, its efforts will help shape the caring and inclusive society that we envision to live in the near future. Mr Robert Chew, PBM, BBM, Chairman

Mr Robert Chew is a Partner at Stream Global and iGlobe Partners, a technology incubator and venture capital firm respectively. He serves on the boards of tech companies - Anacle, Assurity (Chairman), SourceSage and StaffOnDemand, and was previously a partner in Accenture. An eligible organisation may be nominated by a third party with the consent of the organisation. Self-nominations are also accepted.

SHARE AWARD

The SHARE Awards recognise organisations with organisations on SHARE program for their high employees' participation rate. The organisation must have made a minimum annual contribution of \$5,000 and has contributed regularly for at least nine months within the assessment period, but not necessarily for consecutive months.

The various types of SHARE Awards are:

CHARITY AWARD

The Charity Awards are presented to organisations and individuals who have made significant donations to Community Chest. These donations include outright donations, funds raised from events and contributions through SHARE, Community Chest's monthly giving programme.

VOLUNTEER PARTNER AWARD

The Volunteer Partner Award serves to recognise an organisation which is exemplary in its regular volunteerism scheme, such as service-based or skills-based volunteerism, with demonstrated outcomes.

The nominee must have volunteered with a charity that is a member of the National Council of Social Service, and the charity must be supportive of the nomination. The nominee must have staff who volunteer regularly (for example, each staff having volunteered for at least 24 hours and at least 4 times during the assessment period), or have significantly contributed to strengthening the capabilities of the social service agency.

ENABLER AWARD

The Enabler Award serves to recognise organisations and individuals who have offered their talents and/ or resources to benefit the social service sector through Community Chest initiatives.

The contribution towards addressing social needs can be made by the nominee in ways like:

- i. Talent, capability and network including but not limited to the following:
- Offering media assets and resources such as digital/social media/advertising platforms (e.g. print ads, broadcast ads, out-of-home ads etc.)
- Mobilising and connecting people/organisations/partners to support Community Chest in Signature Events, special fundraising projects, etc.

COMMUNITY SPIRIT AWARD

These efforts include outright donations towards The Courage Fund, The Invictus Fund, the IMDA Digital Access Programme and other COVID-related causes; and in-kind donations made to a social service agency through Community Chest for the purpose of serving a need arising from the COVID-19 pandemic.

The two types of Community Spirit Awards are:
